Article 1 Purpose 目的

第一條

To develop a desirable governance system, perfect the supervision functions, and strengthen the management mechanism of the Company's corporate governance, the Rules are established in accordance with the Applicable Listing Rules for compliance.

為建立本公司良好公司治理制度、健全監督功能及強化管理機能，爰依上市櫃法令訂定本規程，以資遵循。

Article 2 Applicable Scope 適用範圍

第二條

The number, term, powers and duties, and meeting rules of this Audit Committee(“**Committee**”), as well as resources to be provided by the Company upon the Committee's exercise of such duties and powers, shall be handled in accordance with the Rules.

審計委員會(下稱「**本委員會**」)之人數、任期、職權、議事規則及行使職權時本公司應提供之資源等事項，依本規程之規定。

Unless otherwise defined in the Rules, any capital letters as used in the Rules shall have the same meanings as defined in the Articles of Association of the Company (as amended or substituted from time to time; hereinafter “**Articles**”).

除本規程另有定義外，本規程所使用任何英文字首大寫之詞彙，其意義應與本公司公司章程(包括其隨時修改或被取代之版本；下稱「**本章程**」)中之定義相同。

Article 3 Supervisory Matters 監督之事項

第三條

The principal purpose for operation of this Committee is supervision of the following matters:

本委員會之運作，以下列事項之監督為主要目的：

1. Appropriate expression of financial statements and reports of the Company.
本公司財務報表之允當表達。
2. Appointment (dismissal), impartiality and performance of the certifying accountant.
簽證會計師之選(解)任及獨立性與績效。
3. Effective enforcement of internal controls of the Company.
本公司內部控制之有效實施。
4. Compliance with relevant laws, regulations and rules by the Company.

本公司遵循相關法令及規則。

5. Monitoring of existing or underlying risks involving the Company.

本公司存在或潛在風險之管控。

Article 4 Composition of the Committee 本委員會之組成

第四條

This Committee shall comprise of all Independent Directors, the number of which shall be no less than three (3). One of them shall be the convenor, and at least one of them shall possess accounting or financial expertise.

本委員會由全體獨立董事組成，其人數不得少於三人，其中一人為召集人，且至少一人應具備會計或財務專長。

The term of Independent Directors of the Committee shall be three years and may be re-elected; where an Independent Directors is removed for any reason, resulting in the number of Independent Directors being less than that prescribed in the preceding paragraph or the Articles, a supplemental election shall be held during the most recent general meeting. Where all Independent Directors are removed, the Company shall convene an extraordinary general meeting within sixty (60) days of occurrence of such fact to elect Independent Directors.

本委員會獨立董事之任期為三年，連選得連任；因故解任，致人數不足前項或本章程規定者，應於最近一次股東會補選之。獨立董事均解任時，本公司應自事實發生之日起六十日內，召開股東臨時會補選之。

Article 5 Powers and Duties 職權事項

第五條

Powers and duties to be exercised by supervisors under the Applicable Listing Rules shall be exercised by this Committee, except those powers and duties stipulated in Article 14-4, Paragraph 4 of Taiwan's Securities Transaction Act.

上市櫃法令對於監察人之規定，於本委員會准用之。

Provisions of Taiwan's Company Act, as enumerated in Article 14-4, Paragraph 4 of Taiwan's Securities Transaction Act, concerning supervisors' acts or representation of the company shall apply *mutatis mutandis* to Independent Director members of this Committee.

臺灣證交法第十四條之四第四項關於臺灣公司法涉及監察人職權之規定，於本委員會之獨立董事準用之。

A resolution by this Committee shall be approved by one-half (1/2) or more of all members; this Committee convenor shall represent this Committee to the public.

本委員會之決議，應有本委員會全體成員二分之一以上之同意；審計委員會之召集人對外代表本委員會。

The Company representatives for the matters related to Articles 213, 214 and 223 of Taiwan's Company Act shall be elected by this Committee in accordance with the

procedures in the preceding paragraph. This Committee may decide to appoint member(s) to represent solely or jointly; If a representative is not elected according to the procedure in the preceding paragraph, all members shall be jointly represented.

公司法第213條、第214條及第223條事項之公司代表人，由本委員會依前項程序選任之，本委員會得決議由成員單獨代表或共同代表；如未依前項程序選任代表人，應由全體成員共同代表。

Article 6 Scope of Powers and Duties 職權範圍

第六條

Duties and powers of this Committee shall be as enumerated in Paragraph 1, Article 119 of the Articles.

本委員會之職權事項如本章程第119條第1項所列。

A resolution regarding the aforementioned matters shall be approved by approval of one-half (1/2) or more of all members of the Committee, and submitted for resolution by the Board of Directors.

前項事項決議應經本委員會全體委員過半數同意，並提董事會決議。

A matter referred to in Paragraph 1 other than Subparagraph (j), Paragraph 1, Article 119 of the Articles, if not approved by one-half (1/2) or more of all members of the Committee, may be undertaken if approved by more than two-thirds (2/3) or more of all Directors.

第一項事項除本章程第119條第1項第(j)款外，如未經本委員會全體委員過半數以上同意者，得由全體董事三分之二以上同意行之。

“All members” referred to in the Rules shall be calculated by the number actually in office. 本規程所稱全體委員，以實際在任者計算之。

The convenor of the Committee shall externally represent this Committee.

本委員會之召集人對外代表本委員會。

Article 7 Procedures of Meetings 會議方法

第七條

Meetings of the Committee shall be convened at least once each quarter, and may be convened from time to time as necessary.

本委員會每季至少召開一次，並得視需要隨時召開會議。

Independent Director members of the committee shall be notified of convention of a committee meeting, by a notice stating the reason(s) for convention of the meeting seven days before the convention; the above does not apply in the event of an emergency.

本委員會之召集，應載明召集事由，於七日前通知本委員會各獨立董事委員。但有緊急情事者，不在此限。

The Committee meetings shall be held in the Company's premises and during its office hours, or in such location and at such time as convenient for the attendance of the

Committee members and as suitable for the convening of the Committee.

本委員會召開之地點與時間，應於公司所在地及辦公時間或便於本委員會成員出席且適合本委員會召開之地點及時間為之。

All members of the Committee shall nominate one from amongst them to act as convenor and chairman of the meeting. However, in the event that a convenor cannot be elected by the members of the Committee, the Independent Director with the most voting rights shall assume the role of the convenor.

本委員會應由全體委員互推一人擔任召集人及會議主席。但本委員會成員無法推選出召集人時，由所得選票代表選舉權最多之獨立董事擔任之。

Where the convenor is on leave or unable to convene a meeting for any cause he or she shall designate another Independent Director member to act as his or her agent; where the convenor has not designated an agent, the Independent Director members of the committee shall nominate one from amongst them to act as such agent.

召集人請假或因故不能召集會議時，由其指定其他獨立董事委員一人代理之；召集人未指定代理人者，由本委員會之獨立董事委員互推一人代理之。

If no fewer than half of the members of the Committee as Independent Directors express in writing their proposals and reasons, they may request the convenor to convene a meeting of the Committee. If the convenor does not convene any meeting of the Committee within fifteen days of such request, no fewer than half of the members of the Committee as Independent Directors may convene the meeting by themselves. 本委員會全體成員二分之一以上之獨立董事得以書面記明提議事項及理由，請求召集人召開本委員會。召集人於請求提出十五日內不為召開本委員會時，本委員會全體成員二分之一以上之獨立董事得自行召集。

The Committee may invite managerial staff from relevant departments of the Company, internal audit staff, accountants, legal consultants or other personnel to attend meetings as guests and provide relevant necessary information. However the said people should leave the meeting when voting.

本委員會得請本公司相關部門經理人員、內部稽核人員、會計師、法律顧問或其他人員列席會議及提供相關必要之資訊。但討論及表決時應離席。

Upon convening the Committee meeting, relevant information shall be prepared and made readily available to the attending Committee members for reference.

本委員會召開時，應備妥相關資料供與會之本委員會委員隨時查考。

Article 8 Method of Resolution 決議方法
第八條

When a meeting of this Committee is convened, a signature book shall be available to record the signatures of Independent Director members present at the Committee for reference.

本委員會召開時，本公司應設簽名簿供出席獨立董事委員簽到，並供查考。

An Independent Director member of the Committee shall attend a Committee meeting in person. If he or she is unable to attend the meeting in person, he or she may appoint another Independent Director member to attend the meeting as his or her proxy; attendance via videoconference is deemed as attendance in person.

本委員會之獨立董事委員應親自出席本委員會，如不能親自出席，得委託其他獨立董事委員代理出席；如以視訊參與會議者，視為親自出席。

A member of the committee appointing another Independent Director member to attend a Committee meeting as his or her proxy shall issue a proxy on every occasion, which shall describe the authorization granted to the proxy agent regarding the reason for convening the Committee meeting.

本委員會委員委託其他獨立董事委員代理出席本委員會時，應於每次出具委託書，且列舉召集事由之授權範圍。

A resolution by this committee shall be approved by one-half (1/2) or more of all members. The result of voting shall be announced immediately and recorded.

本委員會之決議，應有全體委員二分之一以上之同意。表決之結果，應當場報告，並作成紀錄。

Where this committee is unable to convene a meeting for any proper cause, matters may be approved by consent of two-thirds (2/3) or more of all Directors of the Board of Directors, provided that the Independent Director members shall still be required to issue an opinion as to that the resolution is approved in respect of a matter under Subparagraph (j), Paragraph 1, Article 119 of the Articles.

如有正當理由致本委員會無法召開時，應以董事會全體董事三分之二以上同意行之。但本章程第119條第1項第(j)款之事項仍應由獨立董事委員出具同意之意見。

A proxy as described in paragraph 2 above may act as the agent for one person only.

Article 8-1

第八之一條

If the number of the Committee members present does not reach half of the total members at the scheduled meeting time, the chairman may announce a postponement of the meeting on that day, with two postponements at most. If the quorum is still not met after two postponements, the chairman may reconvene the meeting in accordance with the procedures specified in Paragraph 2 of Article 7 hereof.

已屆開會時間，如本委員會出席成員未達全體成員二分之一時，主席得宣布於當日延後開會，其延後次數以二次為限。延後二次仍不足額者，主席得依第七條第二項規定之程序重行召集。

Article 8-2

The Committee shall conduct its proceedings in accordance with the agenda set forth in

the meeting notice. However, any changes may be made to the agenda with the consent of no fewer than half of the members of the Committee.

本委員會應依會議通知所排定之議事程序進行。但經本委員會全體成員二分之一以上同意者，得變更之。

The chairman shall not adjourn the meeting directly without the consent of no fewer than half of the members of the Committee.

非經本委員會全體成員二分之一以上同意者，主席不得逕行宣布散會。

During the proceedings of the Committee, if the number of the members present does not reach half of the total members, the chairman shall announce a temporary suspension of the meeting upon the proposal of the Independent Directors present, and the preceding Article shall apply on a *mutatis mutandis* basis.

本委員會議事進行中，若在席成員未達全體成員二分之一者，經在席獨立董事提議，主席應宣布暫停開會，並準用前條規定。

During the proceedings of the Audit Committee, if the convenor cannot to preside over the meeting for any reason, or if the chairman directly adjourns the meeting without compliance with Paragraph 2 of this Article, Paragraph 5 of Article 7 hereof shall apply *mutatis mutandis* to the selection of their agent.

本委員會議事進行中，召集人因故無法主持會議或主席未依第二項規定逕行宣布散會，其代理人之選任準用第七條第五項規定。

Article 9 Meeting Minutes 議事錄

Proceedings of Committee meetings shall be recorded in the meeting minutes, which shall specify the following matters in detail:

Committee meeting attendance book is part of the meeting minutes of proceedings, and shall be properly kept during existence of the Company.

本委員會簽到簿為議事錄之一部分，應於本公司存續期間妥善保存。

Meeting minutes of proceedings shall be signed or sealed by the chairman and secretary of the Committee meeting, and copies thereof shall be distributed to all Independent Director members of the committee within twenty (20) days of the Committee meeting. The meeting minutes shall be deemed as important files of the Company and be properly kept during existence of the Company.

議事錄須由會議主席及記錄人員簽名或蓋章，於會後二十日內分送本委員會各獨立董事委員，並應列入公司重要檔案，於本公司存續期間妥善保存。

Preparation and distribution of the meeting minutes of proceedings in the first paragraph may be done electronically.

Article 10 Determination of Meeting Agenda 議程之訂定

Agenda for meetings of the committee shall be determined by the convenor. Other members of the Committee may also submit proposals for discussion by Committee

本委員會議程由召集人訂定之，其他委員亦得提供議案供本委員會討論。

Article 11 Recusal fro Meetings 審理之迴避

第十一條

Where an Independent Director member of the committee has a personal conflict of interest in a matter being discussed, the Independent Director shall disclose and explain the material content of such conflict of interest, to the extent that there is likelihood of detriment to interests of the Company, such member shall excuse from the discussion and voting, and shall not vote on proxy of another Independent Director member. In the case that an Independent Director member of the committee 's spouse or a blood relative within second degree of kinship has personal interests in the matters under discussion at a meeting of the Committee in the preceding paragraph, such Independent Director shall be deemed to have personal interests in that matter.

本委員會之獨立董事委員對於會議事項，與其自身有利害關係者，應說明其利害關係之重要內容，如有害於本公司利益之虞時，不得加入討論及表決，且討論及表決時應予迴避，並不得代理其他獨立董事成員行使其表決權。本委員會之獨立董事委員之配偶或二親等內血親，就前開會議之事項有利害關係者，視為獨立董事就該事項有自身利害關係。

Where the Committee is unable to make a resolution due to the preceding paragraph, it shall report the circumstance to the Board of Directors, and the Board of Directors shall make the resolution.

因前項規定，致本委員會無法決議者，應向董事會報告，由董事會為決議。

Article 11-1 Audio Recording or Videotaping of the Committee Meeting as Evidence 本委員會

The Company shall record or videotape any and all of this Committee meetings from beginning to adjournment of the meeting as evidence and the files shall be kept for at least five years. The files may be stored in the electronic form.

本公司應將本委員會之開會過程全程錄音或錄影存證，並至少保存五年，其保存得以電子方式為之。

If a litigation relating to a resolution of this Committee meetings commences before the end of the period in which the evidence shall be kept in the preceding paragraph, the relevant audio recorded or videotaped evidence shall continually be kept until the conclusion of such litigation.

前項保存期限未屆滿前，發生關於本委員會相關議決事項之訴訟時，相關錄音或錄影存證資料應續予保存至訴訟終結止。

For a Committee meeting convened via videoconferencing, the audio recorded and videotaped information shall be deemed as part of the proceedings of minutes of the

Article 12 Appointment of Experts 專家之聘任

第十二條

The committee may resolve to appoint lawyers, accountants or any other experts to undertake the necessary audit or provide consultancy concerning a matter described in Article 6. The costs arising therefrom shall be borne by the Company.

本委員會得經決議委任律師、會計師或其他專業人員，就第六條規定有關之事項為必要之查核或提供諮詢，其所生之費用，由本公司負擔之。

Article 13 Obligations of committee Members 委員之義務

第十三條

Members of the committee shall exercise the care of a good faith manager in faithfully performing the duties and responsibilities set out in the Rules. They shall be accountable to the Board of Directors and shall submit their proposals for resolution by the Board of Directors.

本委員會之委員應以善良管理人之注意，忠實履行本規程所訂之職責，並對董事會負責，且將所提議案交由董事會決議。

Article 14 Regular Review and Authorization of Members 定期檢討及委員之授權

第十四條

The Committee shall regularly review matters relating to the Rules and submit the same for amendment by the Board of Directors.

本委員會應定期檢討本規程相關事項，提供董事會修正。

The committee may authorize the convenor or other members of the Committee to undertake subsequent enforcement of matters resolved by the Committee, who shall submit written or oral reports to the Committee during the period of enforcement. Where necessary, such person/s shall report the matter to this Committee for retroactive recognition or report during the next meeting.

經本委員會決議之事項，其相關執行工作，得授權召集人或本委員會其他委員辦理續行辦理，並於執行期間向本委員會為書面或口頭報告，必要時應於下一次會議提報本委員會追認或報告。

Article 15 Supplementary Provisions 附則

第十五條

The establishment and amendment to the Rules shall be subject to approval of the Board of Directors.

本規程之訂定應經本公司董事會決議通過後施行，修正時亦同。
